Areas: Machine Learning, Deep Learning, Computer Vision, Robotics, NLP, Ethics and Explainability in AI, Autonomous Navigation, Systems for AI and Applications in Manufacturing, Sustainability, Social Media, Astrophysics or Communications.

The advertisement will be open on a rolling basis till a suitable candidate is found. The Google form will not accept applications once the position is filled.

Students admitted through the Visvesvaraya PhD scheme will be encouraged to collaborate primarily with the Department's core faculty.

Eligibility Criteria:

The minimum eligibility criteria is candidates satisfying any one of the following criteria:

Criterion 1: Candidates with a B.Tech/B.E/B.S./M.Sc/MCA in DA/CSE/EE/IT/ECE/MATH/Math & Computing with a first class or a minimum of 6.5 CGPA (or equivalent percentage) in the qualifying examination, and they have a valid GATE DA/CSE/EE/IT/ECE/MATH score.

(OR)

Criterion 2: Candidates with a B.Tech/B.E/B.S./M.Sc./MCA degree in any discipline and having a M.Tech/M.E/M.S. degree in DA/CSE/IT/ECE/EE OR equivalent with a minimum of 6 CGPA (or equivalent percentage) in the qualifying examination.

(OR)

Criterion 3: B.Tech. in DA/CSE/IT/EE/ECE from IITs CFTIs (Centrally Funded Technical Institutes) with a minimum of 8 CGPA (or equivalent percentage) can apply without a valid GATE score.

However, a higher shortlisting criteria may be set by the Department during scrutiny of applications depending on departmental requirement, number, and quality of applicants. Therefore, merely satisfying the minimum eligibility criteria does not guarantee a candidate will be called for an interview, and merely attending an interview does not guarantee admission.
